
Sanction is hereby accorded to the temporary appointment of Mr. Yawar Abbass Bhat S/o Late Ghulam Mohammad Bhat R/o Bemina as Sanitation Worker in the pay level SL1(14800-47100) in Srinagar Municipal Corporation in terms of SRO-43 of 1994.

The appointee shall report to Secretary, Srinagar Municipal Corporation within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/ certificates in original.

1. Academic Qualification Certificate.
2. Date of Birth Certificate.
3. Domicile Certificate.
4. Dependent certificate issued by the Assistant Commissioner, Revenue, Budgam.
5. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
6. All other relevant documents as are required under SRO-43 1994

The appointment of the appointee shall further subject to the following conditions:

- (a) That he shall given an undertaking in the shape of affidavit duly sworn in before Judicial Magistrate to the effect that:
  - (i) If, on verification, genuineness of any of the certificates / documents from the concerned issuing authority is found fake/forged at any point in time, the claim of the appointee for appointment as Sanitation Worker shall also be deemed cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
  - (b) The salary of the appointee shall not be drawn and disbursed to him, unless a satisfactory report in respect of (i) above are received in his favour.
  - (c) The appointee shall be initially on probation for a period of two years.
  - (d) The appointment of the candidate shall be governed by the "New Pension Scheme" (NPS) as per SRO-400 of 2009 dated: 24.12.2009.
  - (e) If the appointee fails to join within a period of Twenty One (21) days from the date of issuance of this order he shall cease his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
