Subject: Celebration of Independence Day on **15th August, 2021-**
Arrangements thereof

CIRCULAR


In view of celebration of Independence Day on **15th August, 2021**, it is impressed upon all officers to have adequate arrangements at the venue **(Sheri-I-Kashmir Cricket Stadium), Srinagar**. In this context, it is hereby ordered that:-

1. The Superintending Engineer (Drainage Circle), SMC shall deploy mobile dewatering pumps at the venue and designated car parking areas in the event of inclement weather, besides he shall also ensure cleaning of the drains in and around the venue.
2. The Executive Engineer (Mech.), SMC shall depute grass cutters to the Sheri-I-Kashmir Cricket Stadium for removal of weeds/grass.
3. The Municipal Veterinary Officer, SMC shall deploy round the clock dog catching squad at the venue to prevent stray animals/dogs in and around the venue.
4. The Chief Sanitation Officer, SMC shall make adequate sanitation in and around the venue and other designated places. He shall ensure Ward Officer, Ward No. 05 and Ward Officer, Ward No. 30 for augmenting manpower to be provided to Ward No. 02 as per the past practice.
5. The Compost Officer, SMC shall deploy two MTVs and Two Sucker Vehicles at the venue two days before the event.
6. The Transport Officer, SMC shall deploy adequate solid waste lifting vehicles at the venue.
7. The Municipal Sanitation Officer (East Zone) is hereby appointed as Nodal Officer who will look after the sanitation and other facilities in and around Sheri-I-Kashmir Cricket. He will also collect Security Passes from SSP Security and submitted to Chief Sanitation Officer, SMC for distribution among the concerned officers/officials.

8. The Ward Officer, Ward No. 01 is directed to remain present along with whole staff and take necessary measures for upto mark sanitation in and around SKICC where "AT HOME" function is scheduled in the evening.
9. The Ward Officers of ward falling adjacent to Sheri-I-Kashmir Cricket Stadium shall keep all the roads neat and clean before the scheduled event.
10. The Ward Officers are directed to make requisition of Conservancy items required by them and Stores Officer. SMC shall provide the items to the Ward Officers immediately after requisition is submitted by the Ward Officers.
11. All officers/concerned who will have to attend Sehri-I-Kashmir cricket Stadium for official duty shall submit the list of officers/officials/Safaiwallas to Chief Sanitation Officer, SMC for issuance of passes. The list shall be furnished within 03 days unflinchingly.

In case of non-compliance, strict action under rules shall be initiated against delinquent officer/official.
